Binoy Kampmark is a Senior Lecturer in the School of Global, Urban and Social Studies at RMIT University, Melbourne, and was a Commonwealth Scholar at Selwyn College, Cambridge University. He is also a contributing editor to CounterPunch.

Darzhan Kazbekova is a Ph.D. candidate in the Social Science program at Syracuse University. She received her master's degree and a Ph.D. in international relations from the Institute of Diplomacy at the Academy of Public Administration in Kazakhstan in 2015. She also holds a certificate in International Relations from the London School of Economics and Political Science and has worked as the Director of the Research Institute at the Academy of Public Administration in Kazakhstan. She is a co-author of "Management in Public Administration", a handbook for government officials in Kazakhstan that was published in 2017 as a short-term project for implementing valuable practices for civil servants in the current Kazakh generation. Her current research project examines policy learning and change among government administrators through an empirical examination of the Kazakhstan government's "Green Economy" policy.

Research interests centre on economic development and international economics. Books include *The Age of Equality: The twentieth century in economic perspective* (Harvard UP, 2011), *The Central Asian Economies in the Twenty-first Century* (Princeton UP, 2019), and *The Economics of European Integration* (Harvard UP, 2021).
