# ANNUAL REPORT OF COUNCIL

AND

## BALANCE SHEET

FOR THE

YEAR ENDING SEPTEMBER 30TH, 1897.

In presenting to you the Twenty-Seventh Annual Report for the year ending September 30th, 1897, your Council have pleasure in announcing that marked progress has been made by the Association, as is evidenced by the substantial increase in the number of Members during the session just ended, the total number on the roll now being one hundred and fifty-three During the year twelve Members, three Associates, and one Student have been elected, one gentleman was re-admitted as a Member, and during the same period, the following named gentlemen have ceased to be connected with the Association:—Messrs. A. D. Marshall, B. Rourke, J. Anderson, S. Brown, J. G. W. Dalrymple, W. Mansfield-Newton, P. T. Owen, F. R. Seaborn, C. Wilkins, and W. Wilson.

Balance Sheet.—An examination of the attached Statement of Accounts and Balance Sheet will show that the financial position of the Association is an extremely satisfactory one, there now being a credit balance in hand of £108 2s. 5d., and this after having paid £35 odd to sundry creditors from

the previous year, and £97 7s. 8d., the cost of publishing Volume IX. of the Association's Proceedings.

Arrears.—In view of the very large amount of arrears of subscriptions, etc., outstanding, viz., three hundred and eight pounds, two shillings and ninepence, and the many unsuccessful appeals to the Members for the payment of same, your Council have reluctantly decided to take immediate legal steps for the recovery of these amounts.

Ex-Members.—The Council have decided to insert in the next and all future volumes of Proceedings, the names of all gentlemen who, for the past five years, have severed their connection with the Association.

As an Exhibition of Mechanical and Electrical Machinery and Progress it was an unqualified success.

Annual Volume.—As announced in the last Annual Report, Volume IX. of the Association's Transactions was published during the year, thanks to the exertions of the Hon. Editor. Mr. H. V. Ahrbecker.

Secretary and Hon. Librarian.—In October your Council re-appointed Messrs. James S. Fitzmaurice and A. M. Howarth, as Secretary and Hon. Librarian respectively for the past year.
