# Extract from Rules of the Associatio...

## Respecting Age and Qualification, Election and Subscription.

Members to be Engineers not under 21 years of age, who may be considered by the Council to be qualified for election.

Associates to be Gentlemen not under 24 years of age, who from their scientific attainments, or position in society, may be considered eligible by the Council.

Student Associ tes to be Students of not less than two years' standing, and not under 24 years of age.

Students to consist only of yours.

Students to consist only of young men over 16 years of age, who are Students in Engineering at a University, or who are apprenticed or articled to any branch of Engineering; and may afterwards be admitted as Members at the discretion of the Council. of the Council.

#### ELECTION.

All recommendations for admission to be signed by not less than five members, if the application be for admission as a Member or Associate, and by three Members it be for a Student.

The elections to take place by ballot; all recommendations for admission to go to the ballot unless unanimously rejected by the Council. The approved ballot list to be signed by the President and copies forwarded to the Members: The ballot list to specify the name, occupation, and address o the Candidates, and also by whom proposed and seconded. Elections to take place at the General Meetings only. Every member when elected shall receive due notice of the same in writing, together with a copy of the Rules of the Association.
