MINUTES OF PROCEEDINGS

OF THE ANNUAL GENERAL MEETING, HELD AT THE SOCIETY ROOMS, 5 ELIZABETH STREET, SYDNEY, ON THURSDAY, OCTOBER 9TH, 1913.

Present.—The President, Mr. G. A. Julius, in the chair, and about 60 members.

Minutes.—The minutes of the previous meeting were read and confirmed.

The President announced that he had received expressions of regret from Mr. A. G. Ambrose and Mr. A. C. Fewtrel on account of their inability to attend that evening, and requested those present to come forward, whereupon he extended to them a personal welcome on behalf of the Association.

Referring to the Notice Paper for the year, the President announced that the paper to be read by Mr. J. A. McEwin would be entitled "Liquid Fuel" instead of "The Bulk Handling of Oil," and the one to be read by Mr. A. W. Tournay-Hinde would be called "Mechanical and Electrical Clocks," instead of "Chronology."

Before proceeding with his address Mr. Reeks remarked that his occupancy of the chair had thrust upon him a duty at once pleasing and sad—sad because it was necessary for him to announce to members present that they were about to lose, for the time being, the companionship of a gentleman whose untiring energy in the interests of the Association largely contributed to the happy position in which members found it that night—and pleasant because, although the occasion did not permit of their singing "For he's a jolly good fellow" (and he was sure everyone thought so), they were at least able to bid him

"bon voyage." Continuing, the President said it was not for him to sing his praises—such an act was unnecessary—and he would content himself with an expression of his belief that, just as his never-failing courtesy, kindness and consideration, as well as his constant cheerfulness had compelled all members to hold Mr. Harricks in the highest respect and esteem, so would these same qualities ensure the arrival of new comrades and friends wherever he might go. Mr. Reeks further remarked that, although the subject of his remarks would soon be out of Sydney, he was sure that neither he nor the members of the Association would be likely to forget the friendship which existed between them, the pleasant comradeship, and intimacy of many years. You are all perfectly well aware of the present position of affairs, and I leave the matter entirely in your hands, awaiting your

"yea" or "nay." The question before you is "That the services of this Association be offered to the Defence Department."

A Member: Is it out of order to ask in what way the Institution will be of use or convenience to the Defence Department?

President: I think that will be left entirely in the hands of the Defence Department. I was careful to say that we offered our services as an Institution, and not as individuals. I am sorry to say I was not present at the Council meeting, but I presume that should any question arise or any point require elucidation, the Defence Department will apply to us, and it will become our business and pleasure to appoint the man best able to deal with it.

I now have rather a painful anl yet pleasurable duty to perform. It was, as you know, the intention that Mr. Cutler should have read a paper to-night, but circumstances arose which rendered it absolutely impossible for him to prepare his paper in time for the meeting, and we fell back—I use a technical term—on our very good friend Mr. Grieve, and I may say—again using a technical expression—that we fell back on a very strong retrenchment. It will now be our pleasure to listen to Mr. Grieve's paper on "Geared Turbines." (Applause.)
