Manuscripts of articles should be no longer than 6000 words (excluding endnotes and the list of works cited), should be set out in Times New Roman 12 pt. font and 1.5 line spacing, and should conform to MLA style in regard to quotations, citations, endnotes and lists of works cited. Manuscripts that do not comply with the Style Guide may be rejected by the editors. Authors are responsible for obtaining copyright permission for any illustrations or figures cited in their texts.
