He is the author of many works in English and German on the works of Rilke, Heinrich von Kleist, 20th century German poetry, and the theory of literature.

She is the author of Modern Japan: A Social and Political History (2002) and co-editor of Being Modern in Japan: Culture and Society from the 1910s to the 1930s (2000). 
