Vattimo's *Art's Claim to Truth* (2008), *Nihilism and emancipation* (2004), and *Richard Rorty and Gianni Vattimo's The Future of Religion* (2005), all published by Columbia University Press and translated into several languages. His forthcoming book is *The Remains of Being*. He also edited *Weakening Philosophy: Essays in Honour of Professor Gianni Vattimo* (2006).

Margherita Zanoletti studies with the Italian Studies, University of Sydney, and is completing her PhD in Art History & Translation on the Australian painter Brett Whiteley (1939-92). Her areas of interest include comparative literature, translation in literature and the visual arts, and art and language.
