## Notes on Contributors

**Eugenio Benitez** is Associate Professor in Philosophy at the University of Sydney, where he teaches in philosophy, classics and ancient history. He is currently working on Plato's *Laws*.

Martin Black received his M.A. from Melbourne University and his Ph.D. from Boston University. His dissertation on the Socratic turn in Plato was supervised by Stanley Rosen. He has published articles on self-knowledge, the crisis of modernity, and Plato. He is currently editing two volumes of uncollected essays of Stanley Rosen's for publication. He teaches courses in philosophy at Boston University and in philosophy and ancient Greek at Suffolk University.

**Mairead Costigan** was a recent recipient of a PhD in Classical Greek Philosophy from the University of Sydney. At the time of her death she was working as a Research Assistant for an Australia Research Council project at the University of New South Wales and was teaching at the Australian Catholic University.

**Jacques Antoine Duvoisin** is a professor at St. John's College in Santa Fe, New Mexico, where he teaches across several disciplines, including philosophy, literature, physics, mathematics and astronomy. He is currently working on a study of Plato's treatment of virtue in the *Meno*, *Protagoras* and *Gorgias*.

Vrasidas Karalis was born in Greece and studied at the University of Athens, where he received his Ph. D. in European literature. He lectured in various colleges and Universities until he was appointed lecturer in Byzantine and Modern Greek studies at the University of Sydney, in 1991. He has published extensively in the areas of Byzantine aesthetics, Greek literature, cultural studies, translation studies, art history and Comparative Literature. He has published articles in scholarly journals on St Paul and the nexus between religion and power. He has edited the book Heidegger and the Aesthetics of Living (2008).

**Harold Tarrant** came to teach Greek at the University of Sydney in 1973 with degrees from Cambridge and Durham Universities. In 1993 he took up the Chair of Classics at the University of Newcastle. He is the author or co-author of several books on Platonism in antiquity, from Plato to Proclus and Olympiodorus.

**Franco V. Trivigno** is Assistant Professor in the Philosophy Department at Marquette University (in Milwaukee, USA). He did his graduate work in the Dual Degree program at Boston University, where he earned a Ph.D. in Philosophy and an M.A. in Classical Studies. His research interests are in ancient philosophy, ethics, and philosophy and literature, in particular, where these three intersect.
