#### ANNUAL GENERAL MEETING.

April 12th, 1905.

HIS Meeting was held in the Geology Theatre. Mr. T. P. Strickland, President, in the chair.

The Minutes of previous Annual General Meeting were read and confirmed. The Hon. Secretary, Mr. R. J. Boyd, B.E., read the Report of the Council for the past session. The Report showed that there were 161 ordinary members, 11 honorary members, and 8 life members, and also dealt with contributions made to the Journal, attendance at Council meetings, and excursions made by the Society. The Report was adopted on the motion of Messrs. Boyd and Barraclough.

The Hon. Treasurer, Mr. H. S. Mort, B.Sc., read the Balance Sheet, which showed a credit balance of £15 5s. 1d The printing of the *Journal* was estimated at £50. The Life Membership Fund had a credit balance of £37 16s., and the Prize Fund a credit of £7 12s. 7d. The financial statements were adopted on the motion of Messrs. Jarman and Flashman.

The annual elections were then made.

Fourteen candidates were elected to membership.

Mr. T. P. Strickland, B.E., M.Sc., after reviewing the Society's position, delivered a Presidential address on "The Multiple Unit System in Electric Traction." Mr. Strickland then introduced the President elect, Mr. J. W. Roberts, B.E., who acknowledged the compliment of his election.

Votes of thanks were accorded to the retiring President for his address, and to the office-bearers of the Society generally, the Hon. Secretary being specially mentioned on his retirement from office, which he had held for three years.

#### ORDINARY GENERAL MEETING.

May 10th, 1905.

The President, Mr. J. W. Roberts, in the chair. Thirty-two members present.

Minutes of previous meeting read and confirmed.

Nine candidates were elected to membership.

The consideration of alterations to the constitution re "Formation of Branch Societies" was postponed.

Mr. W. S. Mort, B.Sc., read a note on the "Wilson Automatic Filter." A lively discussion followed, in which Messrs. Scott, Barraclough, Laby, Jarman, Weston, Strickland, Corlette and Gibson participated.

A hearty vote of thanks was proposed by Mr. Jarman and seconded by Mr. Weston. Mr. Mort replied to the criticisms, and acknowledged the vote of thanks.
